The land tenure is DOGIT under the Trusteeship of the Woorabinda Aboriginal Shire Council and a formal arrangement needs to be entered into to allow Qld Police to continue to use the land.

1. That the Woorabinda Aboriginal Shire Council is the Local Government Authority for the Woorabinda Aboriginal Shire and is the Trustee of the Woorabinda Deed of Grant in Trust (DOGIT)
2. As the Local Government Authority and Trustee for the DOGIT the Council has the responsibility of dealing with the land for the most appropriate use and purpose in the best interest of the community.
3. Council considers that granting Qld Police Service a lease over Lot 169 on plan SP268500 will be for the benefit of the Woorabinda Aboriginal Community as it will enable council to generate additional income from the lease and will mitigate council's liability for damages arising from any incidents that may occur through the current use of the land by Qld Police.
