Regulated Dog

Local Governments are responsible for regulating dogs that are declared dangerous, menacing, or belong to a restricted breed, with the specific requirements managed through the local council and enforced under the Animal Management (Cats and Dogs) Act 2008. Key regulations for owners of these dogs include mandatory microchipping, registration with their local council, and ensuring the dog wears a distinctive red and yellow striped collar in public. Owners must also maintain a child-proof enclosure for the dog on their property and ensure the dog is under effective control, which includes being muzzled, in public.



Declared Dangerous Dog

In Queensland, local governments can declare a dog “dangerous” or “menacing” if it has seriously attacked a person or animal, or acted in a way that causes fear. This declaration, made under the [Animal Management \(Cats and Dogs\) Act 2008](https://www.legislation.qld.gov.au/view/pdf/inforce/current/act-2008-074) <https://www.legislation.qld.gov.au/view/pdf/inforce/current/act-2008-074>, imposes strict controls on the owner, such as mandatory desexing, microchipping, muzzling in public, and keeping the dog in a secure, childproof enclosure. Non-compliance can lead to fines, seizure of the dog, or a destruction notice.

Menacing Dog

In Queensland, “menacing” refers to the local council’s power to declare a dog “menacing” under the [Animal Management \(Cats and Dogs\) Act 2008](#). This declaration is made for a dog that has shown menacing or aggressive behaviour, but has not caused a serious attack, and is a key function of local councils in managing dangerous animals. These declarations result in specific, regulated requirements for the dog and its owner.



Restricted Dog

- A dog is classified as a restricted dog if it is of a breed prohibited from importation into Australia under the Customs Act 1901.
- Restricted breeds include the Dogo Argentino, Fila Brasileiro, Japanese Tosa, American Pit Bull Terrier (or Pit Bull Terrier), and Perro de Presa Canario (or Presa Canario).
